Being one of the Trustees of the Barrington-Countryside Fire Protection District, Cook County, Illinois.

You are hereby notified that the Village of Barrington, Cook and Lake Counties, Illinois, which provides fire protection services, is about to annex the territory hereinafter described pursuant to the provisions of Chapter 24, Paragraph 7-1-13, Illinois Revised Statutes, 1991, and that such annexation will take place not less than ten days after the service of this Notice upon you. The Corporate Authorities of the Village of Barrington intend to consider the annexation of this territory at a meeting to be held at the Barrington Village Hall, 111 West Station Street, Barrington, Illinois at 8:00 p.m. on October 26, 1992. The said territory (real estate) is legally described as follows:

THAT PART OF THE NORTHWEST QUARTER OF SECTION 8, TOWNSHIP 42 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN NOT PREVIOUSLY ANNEXED LYING NORTH OF THE SOUTHERLY RIGHT OF WAY OF THE CHICAGO AND NORTHWESTERN RAILWAY (SAID SOUTHERLY R.O.W. LINE BEING ALSO THE LIMITS OF THE VILLAGE OF INVERNESS PER DOCUMENT NUMBER 19 133 199) AND LYING WESTERLY OF THE EXISTING LIMITS OF THE FOREST PRESERVE DISTRICT OF COOK COUNTY (DEER GROVE) AS DESCRIBED BY DEEDS, DESCRIBED AS FOLLOWS:


BEGINNING AT THE INTERSECTION OF THE EAST LINE OF PUBLIC HIGHWAY (ELA ROAD) AND THE NORTHEASTERLY RIGHT OF WAY LINE OF NORTHWEST HIGHWAY (U.S. ROUTE 14); THENCE SOUTHWESTERLY IN A STRAIGHT LINE TO THE NORTHEAST CORNER OF THE EXISTING VILLAGE LIMITS OF INVERNESS PER DOCUMENT NUMBER 19 133 199, SAID CORNER BEING ALSO THE NORTHEAST CORNER OF INVERNESS ESTATES PER DOCUMENT NUMBER LR 2610834; THENCE NORTHWESTERLY ALONG SAID LIMITS OF THE VILLAGE OF INVERNESS TO THE SOUTHERLY EXTENSION OF THE EAST RIGHT OF WAY LINE OF ROSLYN ROAD; THENCE NORTH ALONG THE SAID EAST RIGHT OF WAY LINE AND EXTENSION THEREOF OF ROSLYN ROAD, SAID LINE BEING THE EXISTING VILLAGE LIMITS OF BARRINGTON, TO THE SOUTH LINE OF CUMNOR ROAD; THENCE EAST ALONG SAID SOUTH LINE AND EXTENSION EASTERLY THEREOF, SAID LINE BEING THE EXISTING VILLAGE LIMITS OF BARRINGTON, TO THE CENTER LINE OF ELA ROAD (LAKE ZURICH ROAD) PER ARTHUR T.
