certain premises in Cook County, Illinois, described as Lot 105 in the resubdivision of Lots 74 to 78 inclusive and Lots 80 to 85 inclusive, together with all easements contained therein, and that part of a public roadway lying northeasterly of the northeasterly line of Graymoor Lane extended from the southerly most corner of Lot 80 to the westerly most corner of Lot 84 and adjoining to Lots 80, 81, 82, 83 and 84, all in Graymoor a subdivision of the north 30 acres of the west 1/2 of the northwest 1/4 and the east 1/2 of the northwest 1/4 of Section 18, township 35 north, range 14, east of the third principal meridian, according to the plat thereof recorded July 8, 1953 as document 15663279, in Cook County, Illinois to secure --- note for One Hundred Twenty Thousand and no/100's DOLLARS.

NOT THEREFORE, in consideration of the premises and of the sum of ONE (1) DOLLAR TO --- in hand paid, the said American National Bank does hereby covenant and agree with the said LaSalle Tallman Bank FSB

as mortgagee that the note owned by said American National Bank and of the mortgage securing same shall be and remain at all times a second lien upon the premises thereby conveyed subject to the lien of the mortgage to said LaSalle Tallman Bank FSB and of the mortgage securing same shall be and remain at all times a second lien upon the premises thereby conveyed subject to the lien of the mortgage to said LaSalle Tallman Bank FSB as aforesaid for all advances made or to be made on the notes secured by said last named mortgage and for all other purposes specified therein.

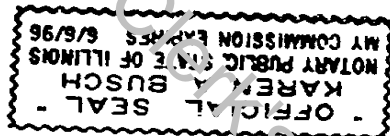
