- 1 Mortgagors shall (1) keep said premises in good condition and repair, without waste: (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep said premises free: from mechanic's liens or liens in favor of the United States or other liens or claims for lien not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note: (3) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (6) comply with all requirements of law or municipal ordinances with respect to previously consented to in writing by the Trustee or holders of the note.
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request. (urnish to Trustee or to holders of the nine the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fine, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the note, under insultance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the note, such rights to be evidenced by the standard rhort-case of insurance about to each policy, and shall deliver all policies, including additional and renewal policies, to holders of the note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- In case of default therein. Trustee or the holders of the note may, but need not, make any payment or perform any act here abefore required of Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on from any tax sale or forfeiture affecting said premises or contest any tax hen or other prior lien or title or claim thereof, or redeem and all expenses paid or incurred in connection therewith, including reasonable attorneys' fees, and any of the parposes herein authorized holders of the note to protect the mortgaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning payable without cotice, advistments thereon at the rate of mise per cent per annum. At the election of the holders of the grancipal note, and without notice to Mortgagors, all unpaid indebtedness secured by this Trust Died shall, not authorizing anything in the principal of the contrary, become due and payable when default shall occur in payment of principal or interest, or in case default shall occur and continue for three days in the performance of any other agreement of the Martgagors.
- T. When the indebtedness hereby secured half become due whether by the terms of the note described on page one or by acceleration or otherwise, holders of the note or Trustee shall jusy the right to foreclose the lien hereof and also shall have all other rights provided by the lines of Illinois for the enforcement of a mortgage orbot, in any suit to foreclose the lien hereof, there shall be allowed and included as additional interests fees, in the decree for sale all expenditures and expess which may be paid or incurred by or on behalf of Trustee or holders of the note for inhich may be estimated as to items to be expended (fer entry of the decree) of procuring all such abstracts of title, title searches and examinations, guarantee policies. Torrens certificates, and similar date and assurances with respect to title as Trustee or holders of the note may deem to proceed the title to or the value of the premises. - 9. Upon or at any time after the filing of a complaint to foreclose this Trust Deed. The Court in which such complaint is filed may appoint is receiver of said premises. Such appointment may be made either before or after sale, without regard to the solvency or insclivency of Mortgagors at the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be appointed as such receiver. Such receiver shall have power to collect the rents issues and profits of said premises during the pendency of such foreclosure suit and, in case or price and a deficiency, during the full stantory such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may are receiver for the intervention of the protection, possession, control, management and operation of the premises during the whole of said pariod. The Court from time to time may decree foreclosing this Trust Deed, or any tax, special assessment or other lien whole or in pair of: (1) The necetedness secured hereby, or by any decree, provided such application is made prior to foreclosure sale; (2) the deficiency in case of a sale and (excleency).
- 10 No action for the enforcement of the lien of this Trust Deed or of any provision hereof shall be subject (Jah) defense which would not be good and available to the party interposing same in an action at law upon the note hereby secured.
- 1.1 Trustee or the holders of the note shall have the right to inspect the premises at all reasonable times and /cc/is thereto shall be permitted for that purpose.
- 12 Trustee has no duty to examine the title, location, existence, or condition of the premises, nor shall Trustee be obligated to record this Trust Deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable for the wils or omissions hereunder, except in case of his own gross negligence or misconduct or that of the agents or employees of Trustee, and he may revite indemnities satisfactory to him before exercising any power herein given.
- 13. Trustee shall release this Trust Deed and the lien thereof by proper instrument upon presentation of satisfactory evidence that all indebtedness secured by this Trust Deed has been fully paid, and Trustee may execute and deliver a release hereof to and at the request of an person who shall either before or after maturity thereof, produce and exhibit to Trustee the principal note, representing that all indebtedness secured has been paid, which representation Trustee may accept as true without inquiry. Where a release is requested of a successor trustee, existe success or trustee hereunder or which conforms in substance with the description herein contained of identification purporting to be exports to be executed by the persons herein designated as the makers thereof; and where the release is requested of the original trustee and he has note herein described any note which may be presented and which conforms in substance with the description herein, he may accept as the gri-other principal note and which purports to be executed by the persons herein designated as makers thereof.
- 14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have been recorded or filed. In case of the death, resignation, inability or refusal to act of Trustee.

  shall be first Successor in Trust and in the event of his or its death, resignation, inability or refusal to act, the then Recorder of Deeds of the county in which the premises are situated shall be second Successor in Trust. Any Successor in Trust hereunder shall have the identical title, powers and authority as are herein given Trustee, and any Trustee or successor shall be entitled to reasonable compensation for all acts performed hereunder.

  - 15 This Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through Mortgagors, and the word "Mortgagors" when used herein shall include all such persons and all persons at any time liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the principal note, or this Trust Deed.
