UNIFORM COVENANTS, DOFFOWER and Lender Covenant and agree as follows: OPY

- 1, Payment of Principal and Interest; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.
- 2. Funds for Taxes and Insurance. - 5. Occupancy, Preservation Maintenance and Protection of the Property; Borrower's Loan Application; Leaseholds. Borrower shall occupy, establish, and use the Property as Borrower's principal residence within sixty days after the execution of this Security Instrument and shall continue to occupy the Proporty as Borrower's principal residence for at least one year after the date of occupancy, unless Lender otherwise agrees in writing, which consent shall not be unreasonably withheld, or unless extenuating direumstances exist which are beyond Borrower's control. - 17. Transfer of the Priperly or a Beneficial Interest in Borrower. If all or any part of the Property or any interest in it is sold or transferred for if a teneficial interest in Borrower is sold or transferred and Borrower is not a natural person) without Lender's prior written content. Lender may, at its option, require immediate payment in full of all sums secured by this Security Instrument.
