Excerpts From Internal Revenue Code

Sec. 6321. Lien For Taxes

If any person liable to pay any tax neglects or rervises to pay title same after demand, the amount (including any intired), additional amount, addition to tax, or assessable panalt, together with any costs that may accrue in addition to enter shall be a filen in favor of the United States upon all property and rights to property, whether real or personal, belonging to such person.

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by taw, the senimposed by section 8321 shall arise at the time the assessment is made and shall continue until the stability for the amount so assessed (or a judgment against the texpayer existing out of such liability) is satisfied or becomes unenforceable by reason of lapse of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Craditors.—The Hendingoser, holder of a security interest, mechanic's lienor, or judgment lien creditor until notice thereof which meets the requirements of subsection (f) has been filed by the Secretary.

(A) Under State Laws

(i) Real Property - In the case of real property, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the law is siturated; and

For purposes of paragraph (2) (8), the residence of a corporation or partnership shall be desmad to be the place at which the principal executive office of the business is located, and the residence of a tempeyer whose residence is without the United filese shall be deemed to be in the District of Columbia.
