Sec. 6321. Lien For Taxes

if any person liable to day any tax neglects or refuses to pay the same after demand, the amount (including any interast, additional amount, addition to tax, or assessable penalty together with any costs that may accrue in addition thereto) shall be a lien in tayor of the United States upon all property and rights to property, whether real or personal, belonging to auch person. 1

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the tien Imposed by section 6321 shall erise at the time the assass-ment is made and shall continue until the liability for the ount so assessed (or a judgment against the taxpayer arising out of such liability) is satisfied or becomes unenforceable by reason of laces of time

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security interests, Mechanic's Lienors, And Judgment Lien Creditors. - The sen imposted by Section 6321 shall not be valid as against any durchaser, holder of a security interest, mechanic's lienor, or judgment lien creditor until notice thereof which meets the require-ments of subsection (f) has been filled by the Secretary.
