13. Loan Charges. If the loan secured by this Security Instrument is subject to a law which sets maximum loan charges, and that law Is finally interpreted so that the interest or other loan charges collected or o be collected in connection with the loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from Borrower which exceeded permitted limit; will be refunded to Borrower.
