That on May 1, 1991, the owner owned the following described land

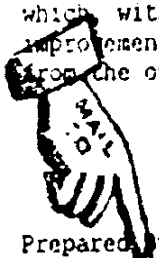
in the County of COOK, State of Illinois to wit:

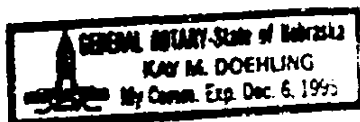
