This Rider, attached to and made part of the Mortgage, Mortgage Deed, Deed of Trust, Security Deed or Vendor's Lien (the "Security Instrument") between JOSEPH F. KOHLER and LINDA S. KOHLER (the "Borrower") and FLEET MORTGAGE CORP. (the "Lender") dated OCTOBER 21, 1992, revises the Security Instrument as follows:

This fee is automatically waived if the assumer is exempt under the provisions of 38 U.S.C. 1829 (b).

Processing Charge: Upon application for approval to allow assumption of this loan, a processing fee may be charged by the loan hold r or its authorized agent for determining the creditworthiness of the assumer and subsequently revising the holder's ownership records when an approved transfer is completed. The amount of this charge shall not ex end the maximum established by the Veteran's Administration for a loan to which section 1814 of chapter 37, title 37, United States Code applies.
- 4. Indemnity Liability: If this obligation is assumed, then the assumer thereby agrees to assume all of the obligations of the veteran under the terms of the instruments creating and securing the loan, including the obligation of the veteran to indemnify the Veterans Administration to the extent of any claim payment arising from the guaranty or insurance of the indebtedness created by this instrument.
