- PAYMENT AND PERFORMANCE. Except as otherwise provided in this Mortgage, Grantur shall pay to Lender all amounts secured by this

Duty to Maintain. Grantor shall maintain the Property in leneritable condition and promptly perform all repairs and maintenance necessary to preserve its value.

Hazardous Substances. Grantor represents and warrants that the Property never has been, and never will be so long or, this Mortgage remains a sen on the Property, used for the generation, manufacture, storage, treatment, disposal, release or threatened release of any hazardous waste or substance, as those terms are defined in the Comprehensive Environmental Response, Compensation and Liability Act or 1980, as amended, 42 U.S.C. Section 9601, et seq. ("CERCLA"), the Superfund Amendments and Reauthorization Act ("SARA"), applicable state-or Federal laws, or regulations adopted pursuant to any of the foregoing. Grantor authorizes Lender and its agents to enter upon the Property to make such inspections and tests as Lender may deem appropriate to determine compliance of the Property with this section of the Mortgage. Grantor hereby (a) releases and waives any future claims against Lender for indemnity or contribution in the event Grantor becomes liable for cleanup or other costs under any such laws, and (b) agrees to indemnity and hold harmless Lender against any and all claims and losses resulting from a breach of this paragraphs of the Mortgage. This obligation to indemnity shall survive the payment of the Indebtedness and the satisfaction of this Mortgage.

Nuisance, Waste. Grantor shall not cause, conduct or permit any nuisance nor commit, permit, or suffer any stripping of or waste on or to the Property or any portion of the Property. Specifically without limitation, Grantor will not remove, or grant to any other party the right to remove, any briber, minerals (including oil and gas), soil, gravel or rock products without the prior written consent of Lender.

Lender's Right to Enter. Lender and its agents and representatives may enter upon the Real Property at all reasonable times to affend to Lender's interests and to inspect the Property for purposes of Grantor's compliance with the terms and conditions of this Mortgage.

Compliance with Governmental Requirements. Grantor shall promptly comply with all laws, ordinances, and regulations of all governmental authorities applicable to the use or occupancy of the Property. Grantor may contest in good faith any such law, ordinance, or regulation and withhold compliance during any proceeding, including appropriate appeals, so long as Grantor has notified Lender in writing prior to doing so and so long as Lender's interests in the Property are not jeopardized. Lender may require Grantor to post adequate security or a surety bond, reasonably satisfactory to Lendar, to protect Lender's interest.

Duty to Protect. Grantor agrees neither to abandon nor leave unaffended the Property. Grantor shall do all other acts, in addition to those acts set forth above in this section, which from the character and use of the Property are reasonably necessary to protect and preserve the Property.

5. COMPLIANCE WITH LEASE. - 7. DUE ON SALE CONSENT BY LENDER. Lender may, at its option, have the right to accelerate, that is, declare immediately due and payable at sums secured by this Mortgage upon the sale or transfer, without the Lender's prior written consent of all or any part of the Reat Property or any interest in the Reat Property. If Grantor sets or transfers the Real Property without the written consent of Lender, then, prior to accelerately or any interest of Grantor. The notice shall provide a period of not less than ten (10) days from the data of the notice within which Grantor may pay the sums declared due. If Grantor fets to pay those sums prior to the expiration of such period, Lender may, without further notice or demand on Grantor involve any remedies permitted in this Mortgage. Advances After Transfer. 9. TAXES AND LIENS. The following provisions relating to the taxes and flors on the Property are a part of this Mongage.

Payment. Grantor shall pay when due (and in all events prior to oblinquency) all taxes, payroll taxes, assessments, water charges and sewer service charges levied against or on account of the Property, and shall pay when due all claims for work done on or for services rendered or material furnished to the Property. Grantor shall maintain the Property free of all tiens having priority over or equal to the interest of Lender under this Mortgage, except for the lien of taxes and assessments out tire, except for the Existing Innebtedness referred to below, and except as otherwise provided in the following paragraph.

Alight To Contest. Grantor may withhold payment of any tax, assessment, or claim in connection with a good fath dispute over the obligation to pay, so long as Lender's interest in the Property is not jeopardized. If a lien arises or is find at a result of nonpayment, Grantor shall within fifteen (15) days after the lien arises or, if a lien is filed, within fifteen (15) days after Brantor has notice of the filing, secure the discharge of the filen or if requested by Lender, deposit with Lender cash or a sufficient corporate surely bond or other society satisfactory to Lender in an amount sufficient to discharge the lien plus any costs and attorneys' fees or other charges that could accrue as a rusuit of a foreclosure or sale under the lien. Evidence of Payment. Grantor shall upon demand furnish to Lender satisfactory evidence of payment of the taxes or assessments and shall authorize the appropriate governmental official to deliver to Lender at any time a written statement of the taxes and assessments against the Property

Notice of Construction. Grantor shall notify Lender at least fifteen (15) days before any work is commenced, any survices are furnished, or any materials are supplied to the Property, if any mechanic's lien, materialmen's tien, or other lien could be asserted on enument of the work, services, or materials and the cost exceeds \$10,000,00. Grantor will upon request of Lender furnish to Lender advance assurance, satisfactory to Lender that Grantor can and will pay the cost of such improvements.

10. PROPERTY DAMAGE INSURANCE. The following provisions relating to insuring the Property are a part of this Mortgage.

Maintenance of Insurance. Grantor shall produce and maintain policies of fire insurance with standard extended coverage endorsements on a reclacement basis for the full insurable value covering all triprovements on the Real Property in an amount sufficient to avoid application of any consurance clause, and with a standard mortgages clause in tayor of Lender. If the Real Property is located in an area designated by the Director of the Federal Emergency Management Agency as a special flood hazard area, Grantor agrees to obtain Federal Flood Insurance to the extent such insurance is required and is available for the term of the toan and for the full unpaid principal balance of the loan. Policias shall be written by such insurance companies and in such form as may be reasonably ecceptable to Lender. Grantor shall deliver to Lender certificates of coverage from each insurer containing a stipulation that coverage will not be cancelled or diminished without a minimum of len (10) days' prior written notice to Lender.

Application of Proceeds. Grantor shall promptly notify Lender of any loss or damage to the Properly if the estimated cost of replacement exceeds \$10,000.00. Lender may make proof of loss if Grantor faits to do so within filteen (15) days of the casualty. If, in Lender's judgment, the restoration or repair is economically leasible and Lander's security is not lessened, insurance proceeds chall be applied to restoration or repair of the damaged Property. If the restoration or repair is not economically leasible or Lender's security would be lessened, the insurance proceeds shall be applied to the sums secured by this Mortgage whether or not then due, with any excess paid to Grantor abandons the Property, or does not answer within thirty (30) days a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may collect the insurance proceeds. Lender may use the proceeds to repair or restore the Property or to pay sums secured by this Mortgage, whether or not then due.

Unexpired insurance at Sale. Any inexpired insurance shall mure to the benefit of, and pass to, the purchaser of the Property covered by this Mortgage at any trustee's sale or other sale held under the provisions of this Mortgage, or at any foreclosure sale of such Property.

Compliance with Existing Indebtedness. During the pariod in which any Existing Indebtedness described below is in effect, compliance with the insurance provisions contained in the instrument evidencing such Existing Indebtedness shell constitute compliance with the insurance provisions.

- 12. WARRANTY; DEFENSE OF TITLE. The following provisions releting to ownership of the Property are a part of this Mortgage.

Title. Grantor warrants that: (a) Grantor holds good and marketable title of record to the Property (including a leasehold interest, if any), free and clear of all liens and encumbrances except those of record, and (b) Grantor has the full right, power, and authority to execute and deliver this Mortgage to Lender.

Defense of Title. Subject to the exception in the paragraph above. Grantor warrants and will forever defend the title to the Property equality the lawful claims of all persons. In the event any action or proceeding is commenced that questions Grantor's title or the interest of Lender under this Mortgage, Grantor shall defend the action at Grantor's expense. Grantor may be the normal party in such proceeding, but Lender shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of Lender's own choice, and Grantor will deliver, or cause to be delivered, to Lender such instruments as Lender may request from time to time to permit such participation.

Compliance With Laws. Granto, withants that the Property and Granton's use of the Property complies with all existing applicable laws, ordinances, and regulations of governments authorities.

13. EXISTING INDEBTEDNESS. The following nill risions concerning existing indebtedness (the "Existing Indebtedness") are a part of this Mortgage.

Existing Lien. The sen of this Mortgage secriting the Indebtedness may be secondary and interior to an existing fien, if there is such a lien Grantor expressly occurrents and agrees to pay, or sive to the payment of, the Existing Indebtedness and to prevent any default on such indebtedness, any default under the instrument, evidencing such indebtedness, or any default under any security documents for such indebtedness.

No Modification. Grantor shall not enter into any agreen ent with the holder of any mortgage, deed of trust, or other security agreement which has priority over this Mortgage by which that agreement is mourfied, amended, extended, or renewed without the prior written consent of Lender. Grantor shall neither request nor accept any future advances under any such security agreement without the prior written consent of Lender.

14. CONDEMNATION. The following provisions relating to condemnation of the Property are a part of this Mortgage.

Application of Net Proceeds. If all or any part of the Property is condumned, Lender may at its election require that all or any portion of the net proceeds of the award be applied to the indebledness under the LOANLINER. Home Equity Plan, subject to the terms of any mortgage or deed of trust with a lien which has priority over this Mortgage. The net proceeds of the award shall mean the award after payment of all reasonable costs, expenses, and afformers' less necessarily paid or incurred by Grantor or Lender in purposton with the condemnation.

Proceedings. If any proceeding in condemnation is field, Grantor shall promptly in youry Lender in writing, and Grantor shall promptly take such steps as may be necessary to defend the action and obtain the award. Grantor shall reimburse Lender for all taxes, as described below, together with all expenses incurred in recording, perfecting or continuing this Mortgage including without limitation all taxes, fees, documentary stamps, and other charges for recording or registering this Mortgage.

Taxes. The following shall constitute taxes to which this section applies: (a) a specific tax upon this type of Mortgage; or upon all or any part of the Indebtedness secured by this Mortgage; (b) a specific tax on Grantor which Grantor is authorized or required to defluct from payments on the Indebtedness secured by this type of Mortgage; (c) a tax on this type of Mortgage chargeable against the Lender or it is colder of the Credit Agreement; and (d) a specific tax on all or any portion of the Indebtedness or on payments of principal and interest made by Grantor.

16. FURTHER ASSURANCES. The following provisions relating to further assurances are a part of this Morigage.

Further Assurances. Upon request of Lender, Granfor will make, execute and deliver, or will cause to be made, executed or delivered, to Lender or to Lender's designee, and when requested by Lender, cause to be filed, recorded, refried, or rerecorded, as the case may be, at such times and in such offices and places as Lender may deem appropriate, any and all such morigages, deeds of trust, security deeds, security agreements, financing statements, continuation statements, instruments or further assurance, certificates, and other documents as may, in the sole coming of Lender, be necessary or desirable in order to effectuate, complete, perfect, continue, or preserve. (a) the obligations of Granfor under the Credit Agreement, this Mortgage, and the Related Documents, and. (b) the tens and security interests created by this Mortgage on the Property. Unless prohibited by law or agreed to the contrary by Lender in writing, Granfor shall reimburse Lender for all costs and expenses incurred in connection with the matters referred to in this paragraph.

- 57. FULL PERFORMANCE. It Grantor pays all the Indebtedness when due, terminates the credit line account, and otherwise performs all the obligations imposed upon Grantor under this Mortgage, Lender shall execute and deliver to Grantor a suitable satisfaction of this Mortgage. - 18. DEFAULT. The notice may be combined or sent with any notice required by applicable law and shall specify: (a) the Event of Default: (b) the action required to cure the default; (c) a date not less than thirty (30) days (or any longer period as required by applicable law or essewhere in this Mortgage) from the date the notice is given to Grantor by which the default must be cured and. (d) that failure to cure the default on or before the date specified in the notice may result in acceleration of the sums secured by this Mortgage and sale of the property. The notice shall further inform Grantor of the right to reinstate after acceleration and the right to assert in a foreclosure proceeding the nonexistence of an event of default or any other defense of Grantor to acceleration and sale. However, if Lender has given Grantor a right to cure with respect to a prior Event of Default which occurred within three hundred sixty—live (365) days of the present event of Default, Grantor shall not be entitled to receive the right to cure described in this paragraph.

20. RIGHTS AND REMEDIES ON DEFAULT. Upon the occurrence of any Event of Default and at any time thereafter, Lender, at its option, may exercise any one or more of the following rights and remedies, in addition to any other rights or remedies provided by tawn.

Accelerate indebtedness. Lender shall have the right at its option to declare the entire indebtedness immediately due and payable.

Mortgagee in Possession. Lender shall have the right to be placed as mortgagee in possession or to have a receiver appointed to take possession of all or any part of the Property, with the power to protect and preserve the Property, to operate the Property preceding foreclosure or said, and to collect the Rents from the Property and apply the proceeds, over and above the cost of the receivership, against the Indebtedness. The mortgagee in possession or receiver may serve without bond if permitted by law. Lender's right to the appointment of a receiver shall exist whether or not the arrow virtivative of the Property exceeds the Indebtedness by a substantial amount. Employment by Lender shall not disquality a person from serving as in receiver.

Judicial Foreclosure. Levider may obtain a judicial decree foreclosing Grantor's interest in all or any part of the Property.

Deficiency Judgment. If primited by applicable law, Lender may obtain a judgment for any deficiency remaining in the indebtedness due to Lender after application of all amounts received from the exercise or the rights provided in this section.

Other Remedies. Lender shall have all other rights and remedies provided in this Mortgage or the LOANLINERS Home Eduty Plan Credit Agreement or available at lew or in equity.

Sale of the Property. To the extent permitted by applicable law, Crantor hereby waives any and at leght to have the property marshalled. In exercising its leghts and remedies, Lender shall bry free to sell all or any part of the Property together or separately, in one sale or by separate sales. Lender shall be entitled to bid at any public sale on all or any portion of the Property.

Notice of Sale. Lender shall give Grantor reasonable nonce of the time and place of any public sale of the Personal Property or of the time after which any private sale or other intended disposition or tile Personal Property is to be made. Reasonable notice shall mean notice given at least ten (10) days before the time or the sale or disposition.

Walver; Election of Remedies. A waiver by any party of a biruph of a provision of this Morigage shall not constitute a waiver of or prejudice the party's rights otherwise to demand strict compliance with that provision or any other provision. Election by Lender to pursue any remedy shall not exclude pursuit of any other remedy, and an election to make experiorurus or take action to perform an obligation of Grantor under this Morigage after failure of Grantor to perform shall not affect Lender's right to declare a default and exercise its remedies under this Morigage.

Attorneys' Fees; Expenses. If Lender institutes any suit or action to entury any of the terms of this Mortgage, Lender shall be entitled to recover such sum as the court may adjudge reasonable as attorneys' fees at that and an any appeal. Whether or not any court action is involved, at reasonable expenses incurred by Lender that in Lender's opinion are necessary if any time for the protection of its interest or the enforcement of its rights shall become a part of the Indebtedness payable on demand and shall priar interest from the date of expenditure until repaid at the Credit Agreement rate. Expenses covered by this paragraph include, without limitation, however subject to any limits under applicable law, Lender's attorneys' fees and legal expenses whether or not there is a lawsuit, including laterneys' fees for bankruptcy proceedings (including efforts to modify or vanate any automatic stay or injunction), appeals and any anticipated post-judgment collection services, the cost of searching records, obtaining title reports (including foreclosure reports), surveyors' reports, and appraisant file), and title insurance, to the extent permitted by applicable law. Grantor also will pay any court costs, in addition to all other sums provided by law.

- 21. NOTICES TO GRANTOR AND OTHER PARTIES. Any notice under this Mortgage, including without initiation any notice of default and any notice of sale to Grantor, shall be in writing and chall be effective when actually delivered or, if mailed, shall be deemed, effective when deposited in the United States mail first class, registered mail, postage prepaid, directed to the addresses shown near the beginning of this Mortgage. Any party may change its address for notices under this Mortgage by giving formal written notice to the other parties, specifying that the propose of the notice is to change the party's address. All copies of notices of foreclosure from the holder of any lien which has priority over this Mortgage. For notice purposes, Grantor agrees to keep Lender informed at all times of circular's current address.
- 22. ASSOCIATION OF UNIT OWNERS. The following provisions apply if the Real Property has been submitted to unit or neighbor lew or similar lew for the establishment of condominiums or cooperative ownership of the Real Property:

Power of Attorney. Grantor grants an irrevocable power of attorney to Lender to vote in its discretion on any matter that may come before the association of unit owners. Lender shall have the right to exercise this power of attorney only after default by Grantor; however, Lender mity decline to exercise this power as it sees fit.

Insurance. The insurance as required above may be carried by the association of unit owners on Grantor's behalf, and the proceeds of such insurance may be paid to the association of unit owners for the purpose of receiving or reconstructing the Property. If not so used by the association, such proceeds shall be paid to Lender.

Compilance with Regulations of Association. Grantor shall perform all of the obligations imposed on Grantor by the declaration submitting the Real Property to unit ownership, by the bytaws of the association of unit owners, or by any rules or regulations thereunder. If Grantor's interest in the Real Property is a leasehold interest and such property has been submitted to unit ownership. Grantor shall perform all of the obligations imposed on Grantor by the lease of the Real Property from its owner.

23. HISCELLANEOUS PROVISIONS. The following miscellaneous provisions are a part of this Mortgage:

Amendments. This Mortgage, together with any Related Documents, constitutes the entire understanding and agreement of the parties as to the matters set forth in this Mortgage. No afteration of or amendment to this Mortgage shall be effective unless given in writing and signed by the party or parties sought to be charged or bound by the afteration or amendment.

Applicable Law. This Morigage shall be governed by and construed in accordance with the laws of the State of Iknos.

Caption Headings. Caption headings in this Morlgage are for convenience purposes only and are not to be used to interpret or define the provisions of this Morlgage.

Grantor's Copy of Documents. Lender agrees to provide Grantor with a conformed copy of both the LOANLINERS Home Equity Plan Credit Agreement and this Mortgage at the time they are executed or within a reasonable time after this Mortgage is recorded.

Merger. There shall be no merger of the interest or estate created by this Mortgage with any other interest or estate in the Property at any time held by or for the benefit of Lender in any capacity, without the written consent of Lender.

Severability. If a court of competent jurisdiction finds any provision of this Mortgage to be invalid or unenforceable as to any person or circumstance, such finding shall not render that provision invalid or unenforceable as to any other persons or circumstances. If feasible, any such offerding provision shall be deemed to be modified to be within the limits of enforceability or validity; however, if the offending provision cannot be so modified, it shall be stricken and all other provisions of this Mortgage in all other respects shall remain valid and enforceable.

Successors and Assigns. Subject to the limitations stated in this Mortgage on transfer of Grantor's interest, this Mortgage shall be binding upon and inure to the benefit of the parties, their successors and assigns. If ownership of the Property becomes vested in a person other than Grantor. Lender, without notice to Grantor, may deal with Grantor's successors with reference to this Mortgage and the indebtedness by way of forbearance or extension without releasing Grantor from the obligations of this Mortgage or liability under the Indebtedness.

Time is of the Essence. Time is of the essence in the performance of this Mortgage.

Waiver of Homestead Exemption. Granfor hereby releases and waives all rights and benefits of the homestead exemption laws of the State of Binois as to all Indebtedness secured by this Morigage.

Wahrers and Construit. Lender shall not be deemed to have warved any rights under this Mortgage (or under the Related Documents) unless such waiver is in writing and signed by Lender. No delay or omission on the part of Lender in exercising any right shall operate as a waiver of such right or any other right. A waiver by any party of a provision of this Mortgage shall not constitute a waiver of or prejudice the party's right otherwise to demand stript compliance with that provision or any other provision. No prior waiver by Lender, nor any course of dealing between Lender and Grantor, shall cries title a waiver of any of Lender's rights or any of Grantor's obligations as to any future transactions. Whenever consent by Lender is required in this Mortgage, the granting of such consent by Lender in any instance shall not constitute continuing consent to subsequent instances where such under its required.
