- If the registered office is changed from one county to another, then the corporation must file with the recorder 4 of deeds of the new county a certified copy of the articles of incorporation and a certified copy of the statement of charge of registered office. Such certified copies may be obtained ONLY from the Secretary of State.
- Any change of registered agent must be by resolution adopted by the board of directors. This statement must **5**. then be signed by the President (or vice-president) and by the Secretary (or an assistant secretary)
- The registered agent may report a change of the registered office of the corporation for which he or she is 6. County Clark's Office registered agent. When the agent reports such a change, this statement must be signed by the registered agent.
