ABSIGNMENT OF RENTS AND LEASING

This Assignment of Rents and Leases ("Assignment") is made as of November 4, 1952, by Cosmopolitan Bank & Trust (as successor Trustee to Cosmopolitan National Bank of Chicago), not personally, but as Trustee under Trust Agreement dated September 26, 1980, and known as Trust No. 25637 ("Trustee") and its beneficiaries, Araceli Aguilar and Jesus Aguilar, husband and wife (collectively "Aguilars") (Trustee and Aguilars are collectively called "Assignor"), having a mailing address at 1512 W. 18th St., Chicago, IL 60608, to U.S. Loan Limited Partnership ("Lender"), having a mailing address at 325 West Huron Street, Suite 612, Chicago, Illinois 60610, and pertains to the real estate described in Exhibit A. which is attached hereto and hereby made a part hereof ("Premises").

I

RECITALS

- 1.1 giaranty and Note. Assignor has executed and delivered to Lender a Guaranty ("Guaranty") of even date herewith, guarantying, among other things, the obligations of N.S.W. As further security for the repayment of the Loan and in consideration of the matters recited hereinabove, Assignor does hereby sell, assign and transfer to Lender all right, title and interest of Assignor (or either of them) in, to any lease or any letting, or any agreement therefor, whether written or verbal, which may have been heretofore or may be hereafter made or agreed to or which may be made or agreed to by Lender under the powers herein granted and all guarantees, amendments, extensions and renewals of said leases or any of them (such leases, agreements therefor, guarantees, amendments, extensions and renewals are hereinafter referred to individually as a "Lease" and collectively as the "Leases"), together with all rents, issues, income, deposits, proceeds, profits and avails now due and which may hereafter become due under or by reason of any of the Leases.

Assignor represents, warrants and covenants that no rent or irstallments for real estate taxes or operating expenses has been or will be paid by any person in possession of any portion of the Premises in excess of one installment thereof paid in advance and that no payment of rent to become due for any portion of the Premises has been or will be waived, conceded, released, reduced, discounted or otherwise discharged or compromised by Assignor without the prior written consent of Lender. Assignor waives any right of set-off against any person in possession of any portion of the Premises. Assignor agrees that it will not assign any of such rents, issues, income, deposits, proceeds, profits or avails.
- 3.2 New Leases or Lease Modification. Assignor shall not enter into any new Lease or agree to any modification of the terms, or a voluntary surrender, of any Lease without the prior written consent of Lender.
- 3.3 Management of Premises. At all times while Lender is not in actual possession of the Premises, Assignor shell use its best efforts to manage the Premises, or to cause the Premises to be managed, in accordance with sound business practices
- 3.4 Future Assignments. To further confirm the assignment made pursuant to this Assignment, Assignor further agrees, from time to time at Lender's request, to execute and deliver any instrument to confirm the assignment and transfer made to Lender of any and all future Leases pertaining to all or any portion of the Premises pursuant to this Assignment by an instrument in form satisfactory to Lender and to execute and deliver to Lender, immediately upon demand of Lender, all such further assurances and assignments pertaining to this Assignment as Lender shall from time to time require.
- 3.5 <u>Authorization to Tenants</u>. Assignor hereby authorizes and directs each tenant named in each of the Leases, or any other future tenant or occupant of the Premises, upon receipt from Lender of written notice to the effect that Lender is then the holder of the Note and Mortgage and that a default exists thereunder or under this Assignment, to pay over to Lender all

DEFAULTS AND REMEDIES

- of Assignor and Lender that this Assignment be a present assignment, it is expressly understood and agreed, notwithstanding anything contained herein to the contrary, that Assignor shall have the right to collect at the time of, but not prior to, the date provided for the payment thereof, all rents, issues, income, deposits, proceeds, profits or avails under the Leases or from the Premises and to retain, use and enjoy the same in accordance with the provisions of this Assignment or of the Loan Documents and unless and until a default has occurred under the Mortgage or any other default in the payment of interest or principal due under the Note or in the performance or observance of any of the other provisions of the Note, the Guaranty, the Mortgage, this Assignment, or any of the other Loan Documents has occurred, Lender shall not exercise any of the rights and powers conferred upon it herein, but nothing herein contained shall be deemed to affect or impair any rights Lender may have under the Note, the Guaranty or the Loan Documents.
- A.2 Right of Possession. In any case in which Lender has a right, under the provisions of the Mortgage, to institute foreclosure proceedings whether before or after a declaration that the entire principal amount secured thereby shall be immediately due, before or after institution of legal proceedings to foreclose the lien thereof, or before or after any sale thereunder). the exercise of the rights and powers conferred upon it herein, without in any way waiving any such default, shall have full power, but without obligation, either in person or by an agent or a receiver appointed by a court, to use and apply the rents, issues, income, deposits, proceeds, profits and avails of the Premises to the payment of or on account of the following, in such order as Lender may in its sole discretion determine:

- (a) operating expenses of the Premises (including, without limitation, costs of management and leasing thereof, which shall include reasonable compensation to Lender and its agents, if management be delegated thereto, and lease commissions and other compensation and expenses of seeking and procuring tenants and entering into leases), establishing any claims for damages, and premiums on insurance authorized hereunder or required to be maintained pursuant to the Loan Documents;
- (b) taxes, special assessments and water and sewer charges on the Premises now due or that may hereafter become due;
- (c) the cost of any and all repairs, rebuilding, restoration, decoration, renewals, replacements, alterations, additions, batterments and improvements to the Premises (including, without limitation, the cost from time to time incurred to install or replace ranges, refrigerators and other appliances or other personal property therein, and the cost of placing the Premises in such condition as will, in the sole judgment of Lender, make them readily rentable or salable);

Should Lender incur any such claims, demands, liability, loss, cost, expense or damage under the Leases or any such agreements, under or by reason of this Assignment thereof, or in the defense of any claims or demands relating thereto, Assignor shall reimburse Lender for the amount thereof (including, without limitation, costs, expenses and reasonable attorneys' fees) immediately upon demand with interest at the Default Rate (as that term is defined in the Note) from the date of such demand and all such amounts shall, until paid, be and become additional amounts secured hereby and by the Loan Documents.
- 4.5 <u>Limitation of Liability</u>. Nothing contained in this Assignment shall be construed as making or constituting Lender a "mortgagee in possession" in the absence of the taking of actual possession of the Premises by Lender pursuant to the provisions

hereinafter set forth. This Assignment shall not operate to place responsibility for the control, care, management or repair of the Premises upon Lender, nor for the carrying out of any of the terms and conditions of any of the Leases; nor shall it operate to make Lender responsible or liable for any waste committed on the Premises by any tenant or other party in possession or for any dangerous or defective condition of the Premises or for any negligence in the management, upkeep, repair or control of the Premises resulting in loss or injury or death to any tenant, licensee, employee or stranger, and Assignor hereby agrees for itself and for all other persons claiming by, through or under Assignor that in the exercise of the powers herein granted Lender, no liability shall be asserted or enforced against Lender, all such liability being expressly waived and released by Assignor.

- that no judgment or decree entered on any debt secured or intended to be socured by any of the Loan Documents shall operate to abrogate or lessen the effect of this Assignment, but the same shall continue in full force and effect until such time as the payment and discharge of any and all indebtedness evidenced or secured by such Loan Documents, in whatever form such indebtedness may be, in full and all bills incurred by virtue of the authority contained herein have been paid in full out of the rents, issues, income, deposits proceeds, profits and avails of the Premises by Assignor or by any quarantor of payment of the Note, or until such time as this Assignment is voluntarily released. This Assignment shall also remain in full force and effect during the pendency of any foreclosure proceedings pursuant to the Mortgage, both before and after sale, until the issuance of a deed pursuant to a foreclosure decree, unless the indebtedness secured by the Mortgage is fully satisfied before the expiration of any period of redemption.
- 4.7 Nature of Rights and Remedies. All rights and remedies set forth in this Assignment are cumulative, and Lender may recover judgment thereon, issua execution therefor, and resort to every other right or remedy available at law or in equity, without first exhausting and without effecting or impairing the security of any right or remedy afforded hereby; and no such right or remedy set forth in this Assignment shall be deemed exclusive of any of the remedies or rights granted to bender in the Note, in the Mortgage or in any of the Loan Documents. Unless expressly provided to the contrary in this Assignment, no consent or waiver, express or implied, by any interested party referred to herein to or of any breach or default by any other interested party referred to herein in the performance by such other party of any obligations contained herein shall be deemed a waiver by such party of the performance of, or a consent to the failure to perform, any obligations contained herein or a consent to the performance by any such other interested party referred to herein of any obligations contained herein.
