JOURNAL ENTRY OF JUDGMENT

THIS MATTER coming on before the undersigned on this 23 day of June, 1992, for consideration of the entry of a default judgment against the Defendant, Alan S. Golboro. The Court after reviewing the file and being fully advised in the premises finds as follows:

This is an action for collection of an open account and venue is proper in this Court pursuant to 12 O.S. § 142(b) (1987).

The Defendant, Alan S. Golboro, was properly served with summons on the 1st day of June, 1992. Service was accomplished in compliance with this Court's Order issued on May 26, 1992, authorizing special service by certified mail, receipt of which was acknowledged by Alan S. Golboro on June 1, 1992, according to the green card returned and duly filed in this case on June 4, 1992. The Defendant has not answered nor entered an appearance.

As a result of the foregoing, the Court finds that it has jurisdiction of both the subject matter of this action and of the parties hereto. The Court further finds that all of the

allegations in Plaintiff's Petition are true and that the Plaintiff is therefore entitled to a judgment in personam against said Defendant, Alan S. Golboro, in the amount of \$20,743.52; together with pre-judgment interest at 18% per annum from the 29th day of February, 1992, until date of judgment, in the amount of \$1,155.96, all as provided in the invoices forwarded to Defendant in representing said open account; and post-judgment interest at 18% per annum in the amount of \$10.23 per diem, until said judgment amount is paid.

The Court further finds that Plaintiff is entitled to a reasonable attorneys' fee and its costs, as a prevailing party pursuant to 12 O.S. § 936, and that a reasonable attorneys' fee and costs should be entered in the amount of \$3100⁰⁰.

IT IS THEREFORE ORDERED ADJUDGED AND DECREED that the Plaintiff have and recover judgment in personam against the Defendant, Alan S. Golboro, in the amount of \$20,743.52, with interest at 18% per annum from the 29th day of February, 1992, until date of judgment, in the amount of \$1,155.96; post-judgment interest thereafter at 18% per annum in the amount of \$10.23 per diem, until paid; together with attorneys' fees and costs of this action in the amount of \$3100⁰⁰, for all of which let execution issue.
