## POWER OF ATTORNEY

ILLINOIS STATUTORY SHORT FORM POWER OF ATTORNEY FOR PROPERTY

POWER OF ATTORNEY made this 12<sup>th</sup> of NOVEMBER, 1992.

1. I, AMY R. SMITH, hereby appoint: RONALD D. 3. My agent shall be entitled to reasonable compensation for services rendered as agent under this power of attorney.


