THIS BALLOON NOTE ADDENDUM is made this 18th

and is incorporated into and shall be deemed to amend and supplement the Balloon Note made by the undersigned (the "Bestower") in a liver of

IMERICAN HOME FINANCE, INC.

(the "Lender")

and dated as of even date herewith (the "Note"). The interest rate stated on the Note is called the "Note Rate." The date of the Note is called the "Note Date."

I (the Borrower) understand the Lender may transfer the Note, the related Mortgage, Deed of Trust or Deed to Secure Debt (the "Security Instrument") and this Addendum. The Lender or anyone who takes the Note, Security Instrument and this Addendum by transfer and who is entitled to receive payments under the Note is called the "Note Holder."

ADDITIONAL COVENANTS. In addition to the covenants and agreements in the Security Instrument, Borrower and Linder further covenant and agree as follows (despite anything to the contrary contained in the Security Instrument or the Note):

1. CONDITIONAL RIGHT TO REFINANCE

At the maturity date of the Note and Security Instrument (the "Maturity Date"), I will be able to obtain a new loan ("New Loan") with a new Maturity Date of Decamber 1 , 20 22 , and with an interest rate equal to the "New Note Rate" desertained in accordance with Section 3 below if all the conditions provided in Sections 2 and 5 below are met (the "Conditional Refinancial Continuous or Conditions are not met, I understand that the Note Holder is under no obligation to refinance or modify the Nate. Or to extend the Maturity Date, and that I will have to repay the Note from my own resources or find a leader willing to lend me the money to repay the Note.

2. CONDITIONS TO OPTION

If I want to exercise the Conditional Refinancing Option at manurity, certain conditions must be met as of the Maturity Date. These or additions are: (1) i must still be the owner and recupant of the property subject to the Security Instrument (the "Property"); (2) I must be current in my monthly payments and carried have been more than 30 days late on any of the 12 scheduled monthly payments in mediately preceding the Maturity Date; (3) no tien against the Property (except for taxes and special assessments not yet due and payable) other than that of the Security Instrument may exist; (4) the New Note Rate cannot be more than 5 percentage points above the Note Rate; and (5) I must make a written request to the Note Holder as provided in Section 5 below.

If this required net yield is not available, the Note Holder will determine the New Note Rate by using comparable information.

4. CALCULATING THE NEW PAYMENT AMOUNT

Provided the New Note Rate as calculated in Section 3 above is not greater 1973. 5 percentage points above the Note Rate and all off or conditions required in Section 2 above are satisfied, the Note Holder will determine the amount of the monthly payment that will be sufficient to repay in full (a) the unpaid principal, plus (b) accrued but unpaid interest, plus (c) all other sums I will owe under the Note and Security Instrument on the Maturity Date (assuming my monthly payments the ore current, as required under Section 2 above), over the term of the New Note at the New Note Rate in equal monthly payment. The Note Holder will calculate the net New Note Rate based upon the Federal National Mortgage Association's applicable published required net yield in effect on the due and time of day notification is received by the Note Holder and as calculated in Section 3 above. I will then have 30 calendar days to provide the Note Holder with acceptable proof of my required ownership, occupancy and property lien status. Before the Maturity Date the Note Holder will advise me of the new interest rate (the New Note Rate), new monthly payment amount and a date, time and place at which I must appear to sign any documents required to complete the required refinancing. I understand the Note Holder will charge me a \$250.00 processing fee and the costs associated with updating the title policy, if any, and any reasonable third-party costs, such as documentary stamps, intangible tax, survey, recording fees, etc.
