That on or about January 15, 1992, the Owner owned the land in Cook County, State of Illinois, more specifically described in the attached Exhibit "A" and commonly known as 222 West Adams Street, Chicago, Illinois, and Morse Diesel was Owner's contractor for the improvements thereof.

That on or about November 25, 1991, the claimant entered into an agreement with Harmon Contract W.S.A., Inc., a subcontractor to Morse Diesel for the total sum of \$938,145.10, commencing on January 15, 1992, to furnish exterior wall panels.

That said claimant is entitled to credits on account for the above materials, totaling \$725,242.34, leaving due unpaid and owing to the claimant, after allowing all credits, the balance of \$212,902.76, for which, with interest, the claimant claims a lien on said land and improvements and on the money or other
