## MODIFICATION AGREEMENT

- D. Borrower and Lender mutually desire to modify the terms and conditions of the Note and Mortgage.

NOW, TRIKSFORE, the parties, notwithstanding anything contained to the contrary in the Note or mortgage agree as follows:

- The per annum interest rate on said Note will change to 7.375% effective November 1, 1992.
- 2. The monthly principal and interest payment will change to \$441.46 effective December 1, 1992 and monthly thereafter until the final payment on November 1, 1997. The rayment is based on the scheduled principal balance of \$48,849.49 remaining as of the interest change date and the remaining amortization term of 186 months.
- Except as modified by this Modification Agreement, all of the provisions of the Note and Mortgage shall remain in full force and effect.
