Building line conditions and restrictions, which shall run ad front
until January 1, 1944, as shown in Plat of 5th Ward as set up by Plan
12, 1941, in Book 111 of Plats, Page 7, affecting lots 1 to 47 facing Rockwell
Street and shown in Plat of record 1, Document No. 127673.
These restrictions, conditions and covenants affect the size, use and
use and character of buildings to be erected, the location of water
wells and quantity of water to be used, disposal of same to be
constrained. (See Deed and) Change in Building Line Restrictions
dated October 30, 1943, and recorded as Document No. 127673, changing
building line restrictions on certain lots contained in said Plat, as follows:
Lots 2, 26, 29, 34, 41 and 44, each having a 25 foot building line restriction
on one side of each of the lots, shall be changed so as the said 25 foot
building line restriction on each of the aforementioned lots is reduced

Street is to remain in full force and effect.
