(510.00) in hand paid, and such other good and valuable consideration, the receipt and sufficiently of which is hereby mutually acknowledged, the Borrowers, the Lender, and the Subordinating Party do hereby covenant and agree that the Note and Mortgage/Trust De id in favor of the Subordinating Party, and all of the terms, covenants and conditions thereof, are made subject, subordinate and inferior to file Note, Mortgage/Trust Deed and Assignment of Rents, and any other agreement in favor of the Lender, acting as pecurity for said Note, and all advances made or to be made thereof.
