AN ORDINANCE AMENDING CHAPTER 41A
ENTITLED "REAL ESTATE TRANSFERS" OF THE
CODE OF THE VILLAGE OF ELMWOOD PARK

Section 1. Section 41A-3 of Chapter 41A entitled "Real

hereby amended by amending subparagraph (c) thereof as follows:

(c) A processing fee in the amount of \$35.00.
