for a total of \$1800.00

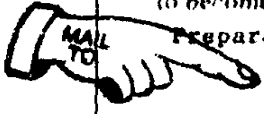
leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of \$1800.00 Dollars, for which, with interest,

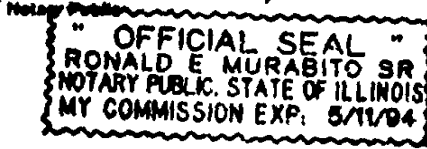
