NOW, THEREFORE, the RESOLUTION TRUST CORPORATION, as RECEIVER OF UNITED SAVINGS OF AMERICA, for value received does hereby grant, sell, assign transfer, set over and convey to FEDERAL HOME LOAN MORTGAGE CORPORATION ("Assignee"), its successors and assigns without any warranties any interest the Assignor may have in a Mortgage dated June 10, 1978, made and executed by Fortunato M. 
AFFIDAVIT OF NOTIFICATION OF ASSIGNMENT OF MORTGAGE

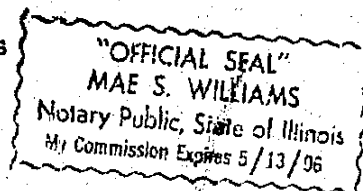
