ASSIGNMENT OF MORTGAGE

NOW, THEREFORE, the RESOLUTION TRUST CORPORATION, as RECEIVER OF UNITED SAVINGS OF AMERICA, for value received does hereby grant, sell, assign transfer, set over and convey to FEDERAL HOME LOAN MORTGAGE CORPORATION ("Assignee"), its successors and assigns without any warranties any interest the Assignor may have in a Mortgage dated September 13, 1983, made and executed by Herman Rendon and Patricia Rendon, his Wife, as Mortgagor(s), to United Savings of America given to secure the obligations evidenced by a Note given by the Mortgagor(s) to the Mortgagee, and registered September 16, 1983, in the office of the Registrar of Cook County, State of ILLINOIS, as Document No. 3330154 covering the property described in Exhibit A attached hereto, together with the Note, debt and claim secured by the Mortgage.
