SUBORDINATION AGREEMENT

WHEREAS, Michael Sasso, Jr. and Patricia Sasso, his wife by a first mortgage dated January 8, 1992 and recorded in the Recorder's Office of Cook County, Illinois as Document No. 92-036617, did convey unto First Chicago Bank of Ravenswood as Successor to The First National Bank of Chicago certain premises in Cook County, Illinois, described as:

WHEREAS, the note secured by the said first mortgage are held and owned by First Chicago Bank of Ravenswood As Successor to The First National Bank of Chicago who desires to subordinate the lien of the first mortgage securing the same to the lien of the mortgage as Document No. _____ secondly above described.

NOW THEREFORE, in consideration of the premises and of the sum of ONE (1) dollar to First Chicago Bank of Ravenswood As Successor to The First National Bank of Chicago in hand paid, the said First Chicago Bank of Ravenswood As Successor to The First National Bank of Chicago does hereby covenant and agree with the said First Chicago Bank of Ravenswood As Successor to The First National Bank of Chicago and of the mortgage securing same shall be and remain at all times a second lien upon the premises thereby conveyed subject to the lien of the mortgage to said The First National Bank of Chicago as aforesaid for all advances made or to be made on the notes secured by said last named mortgage and for all other purposes specified therein.
