THIS MODIFICATION OF MORTGAGE IS DATED OCTOBER 28, 1992, BETWEEN Samuel R. Harris and Janice L. Harris, his wife, (referred to below as "Grantor"), whose address is 235 Red Coach Ln., Northbrook, IL 60062; and FIRST NATIONAL BANK OF NORTHBROOK (referred to below as "Lender"), whose address is 1300 Meadow Road, Northbrook, IL 60062.

MORTGAGE. Grantor and Lender have entered into a mortgage dated April 13, 1987 (the "Mortgage") recorded in Cook County, State of Illinois as follows:

Mortgage dated 10/21/91 recorded in the Recorders office of Cook County on 11/05/91 as Document #91579200

REAL PROPERTY DESCRIPTION. The Mortgage covers the following described real property (the "Real Property") located in Cook County, State of Illinois:

Lot 49 in Williamsburg Square of Northbrook Unit No. 2, being a Subdivision in the Northeast 1/4 of Section 3, Township 42 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois.

The Real Property or its address is commonly known as 235 Red Coach Ln., Northbrook, IL 60062. The Real Property tax identification number is 04-03-204-013.

MODIFICATION. Grantor and Lender hereby modify the Mortgage as follows:

The remaining unpaid indebtedness of \$47,000.00 is extended to 10-28-93 and shall be repaid in monthly installments of interest commencing 11-30-92; the final installment shall be the entire remaining balance of principal and interest and shall be due 10-28-93. All payments shall include interest on the unpaid principal balance from time to time at a variable rate of WSJ* + 1% per annum. The mortgage and note secured therein are accordingly extended to 10-28-93.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorser to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

EACH GRANTOR ACKNOWLEDGES HAVING READ ALL THE PROVISIONS OF THIS MODIFICATION OF MORTGAGE, AND EACH GRANTOR AGREES TO ITS TERMS.

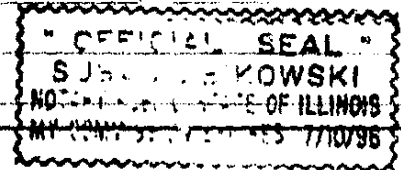
