

ORDINANCE NO.: 92-0-3

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE NORTH RIVERSIDE PUBLIC LIBRARY DISTRICT, COOK COUNTY, ILLINOIS

WHEREAS, the Village of North Riverside is included within the North Riverside Public Library District; and,

whereas, the Village of North Riverside by ordinance enacted on the 21st day of March 1988 and known as Ordinance No. 88-0-6, annexed certian territory known as the Des Plaines Avenue Cemetery Association Property (hereinafter the "Territory"); and,


Whereas, the Territory annexed by the Village of North Riverside is not within any tax supported library district; and,

Whereas, the President and Board of Trustees of the North Riverside Public Library District finds that it is in the best interests of the District to annex the Territory in accordance with the Public Library District Act.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the North Riverside Public Library District, as follows:

<u>Bection 1:</u> The foregoing recitals are incorporated in and made part of this Ordinance.

section 2: The Territory described on Exhibit A attached hereto and made part hereof is hereby annexed to the North Riverside Public Library District, Cook County, Illinois. The Plat

of Annexation attached hereto as Exhibit B illustrates the Territory and is hereby adopted as the official Plat of Annexation for the Territory.

gettion 3: Within 15 days of the date of adoption of this Ordinance, the Secretary shall cause the publication of notice of the adoption of this Ordinance in one or more newspapers published in the District and the Territory being annexed.

Secretary shall send or cause to be sent to the President and board of Trustees of each public library with territory within one mile of the Territory, notice of the adoption of this Ordinance, in substantially the same form as that Notice which is attached hereto as Exhibit C; a copy of the text of the publication notice described in section 3 hereof; and a copy of a map showing the boundaries of the Territory.

preparation of a form of petition requesting that the question of the adoption of the ordinance be submitted to the voters of the District or the Territory, or both, in substantially the same form as that which is attached hereto as Exhibit D. The Secretary shall provide a Petition to any individual requesting one.

<u>Section 6:</u> The Secretary is hereby directed to record with the Recorder of Deeds and to file with the County Clerk a certified copy of this Ordinance, together with the Plat of Annexation.

<u>Bection 7:</u> This Ordinance shall be in full force and effect from and after its passage, approval and publication in accordance with law.

EXHIBIT A

A tract of land, being part of Block 1 and parts of Lots 3 and 4 in the Partition of Stephan Whitney's Estate, a Subdivision of the South half of Section 24, Township 39 North, Range 12, East of the Third Principal Meridian, bounded and described, as Follows:

Point of Commencement being the Southeast corner of said Section 24; thence Northerly along the East line of said Section 24, a distance of 1334.0 feet; thence Westerly, a distance of 33 feet to the Point of Beginning (said point also being the Southeast corner of said Block 1); thence Northerly along a line 33 Feet West of and parallel to the East line of said Section 24, a distance of 1334.0 Feet; thence Westerly along the North line of the East half of the Southeast Quarter of said Section 24 a distance of 1141.7 feet; thence Southerly, a distance of 2086.8 Feet; thence Easterly, a distance of 487.42; thence Southerly, a distance of 56.5 Feet; thence Northerly, a distance of 14.13 Feet; thence Easterly, a distance of 588.44 feet to the Point of Beginning, all in Cook County, Illinois.

Being a tract containing 1,938,551.1 square Feet or 44.5032 acres.

The foregoing Ordinance will automatically take effect unless, on or before the 1st day of February, 1993, a petition is filed with the Board of Trustees of the North Riverside Public Library District, at the office of the Director of the North Riverside Public Library, signed by 454 voters (10% of the registered voters in the District), asking that the question of the annexation of the Territory be submitted to the voters thereof. If a petition or petitions bearing the requisite number of signatures is filed on or before the aforementioned date, then the question of the adoption of the annexation ordinance will be submitted to the voters of the District on the 20th day of April, 1993.

Pecition forms have been prepared by the Secretary of the Board and are available to any individual requesting one at the offices of the North Riverside Public Library, 2501 Des Plaines Avenue, North Riverside, Illinois.

A copy of the annexation ordinance, including the Plat of Annexation and other exhibits thereto, is available for inspection at The North Riverside Public Library District, 2501 Des Plaines Avenue, North Riverside, Illinois, 60546.
