This Correction Agreement dated as of December 17, 1992 (this "Agreement"), is entered into by and between IVEX COATED PRODUCTS CORPORATION, a Massachusetts corporation, as successor in interest to L&CP Corporation ("Mortgagor"), and SOCIETE GENERALE, SOUTHWEST AGENCY, a French banking corporation, as successor in interest to Creditanstalt-Bankverein ("Assignee"). All capitalized terms not defined herein shall have the meaning assigned to them in the Modification Agreement (hereinafter defined).

WITNESSETH:

WHEREAS, Mortgagor and Assignee made and entered into that certain Modification of Construction Mortgage, Assignment of Leases and Rents, Security Agreement and Financing Statement dated as of December 17, 1992 (the "Modification Agreement"), which Modification Agreement covers, among other property, the real property described on Exhibit A attached hereto and incorporated herein for all purposes;
