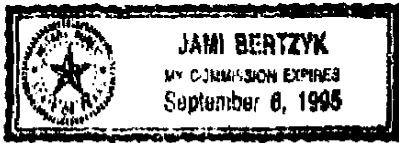
B. That at the time I acquired the land I was a single person.
