ORDINANCE NO. 92-0-69

AN ORDINANCE VACATING AN ALLEY IN THE VILLAGE OF WILMETTE, COOK COUNTY, ILLINOIS

WHEREAS, the President and the Board of Trustees of the Village of Wilmette, Illinois, after due investigation and consideration, have determined that the alley hereinafter described is adjoined on both sides by private uses, has never been opened and will not be used by the general public as an alley and is no longer required for public use, and that the public interests will be subserved by vacating said parcel; and

WHEREAS, in the opinion of the President and Board of Trustees, the relief to the public from the further burden of responsibility for said alley would be adequate compensation for the vacation of the alley hereinafter described;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Wilmette, Cook County, Illinois:

SECTION 1: That the alley hereinafter described is no longer required for public use and the public interests will be subserved by vacating said alley.

SECTION 2: That the heretofore dedicated alley, legally described as:

All of the 7-foot east-west alley in Block 1 in E. T. Paul's Addition to Wilmette; being the West 1053.3 Feet of the Fractional South Half of the Fractional South East Quarter of Fractional Section 28, Township 42 North, Range 13, East of the Third Principal Meridian; lying West of the West Line of 17th Street extended North and East of the East Line of 18th Street extended North, in Cook County, Illinois;

which said premises are shown on the attached plat, which plat for greater certainty is made a part of this ordinance, BE AND THE SAME ARE HEREBY VACATED AND CLOSED AND DIVIDED at the centerline of each alley, except for 100 feet of the 16-foot east-west alley immediately east of Princeton Place and lying between Lot 1 in Nagel's Resubdivision of Lots 7, 8, 9 and 10 of Block 9 in First Addition to Kenilworth and Lot 11 in First Addition to Kenilworth, a subdivision in Section 29-42-13, which shall be divided as 12 feet joined to Lot 11 and 4 feet joined to Lot 1, as shown on said Plat of Vacation.

SECTION 3: A certified copy of this ordinance shall be filed by the Village Clerk of the Village of Wilmette, Illinois, for recording in the office of the Recorder of Deeds in Cook County, Illinois, within sixty days after the passage of this ordinance.

SECTION 4: This ordinance shall be in full force and effect from and after its passage, approval and publication, according to law.
