THIS INDENTURE, made January 7, 1992, between RUDINE M. TUCKER

herein referred to as "Mortgagors", and CHICAGO TITLE AND TRUST COMPANY, an Illinois corporation doing business in Chicago, Illinois, herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS the Mortgagors are justly indebted to the legal holder or holders of the principal Promissory Note hereinafter described, said legal holder or holders being herein referred to as Holders of the Note, in the Principal Sum of

SEVENTEEN THOUSAND and no/100 (\$17,000.00)-----DOLLARS, evidenced by one certain Principal Promissory Note of the Mortgagors of even date herewith, made payable to THE ORDER OF ~~BEARER~~ FRED H. TUCKER, JR. and STEPHANIE R. TUCKER, or the survivor of them, and delivered in and by which said Principal Note the Mortgagors promise to pay the said principal sum on December 7, 1995 with interest thereon from January 7, 1992 until maturity at the rate of 5.63 per cent per annum, payable semi-annually on the 1st day of January and of July in each year, all of said principal and interest bearing interest after maturity at the rate of 7.07 per cent per annum, and all of said principal and interest being made payable at such banking house or trust company in Schaumburg, Illinois, as the holders of the note may, from time to time, in writing appoint and in absence of such appointment, then at the residence of obligors.

NOW, THEREFORE, the Mortgagors to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this trust deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee, its successors and assigns, the following described Real Estate and all of their estate, right, title and interest therein, situate, lying and being in the VILLAGE OF SCHAUMBURG COUNTY OF COOK AND STATE OF ILLINOIS, to wit:

Lot 92 of Kingsport Village Unit 1, being a subdivision of part of the North 15 chains (990 feet), of the Southeast 1/4 of Section 27, Township 41 North, Range 10 East of the Third Principal Meridian, in the Village of Schaumburg, Cook County, Illinois.

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purposes, and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.

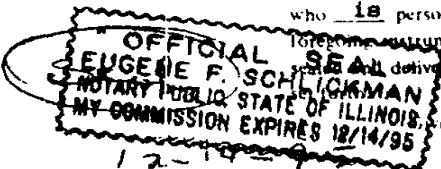
