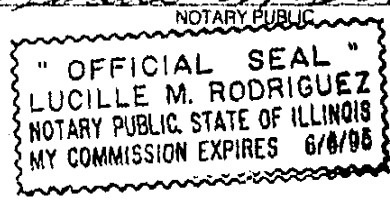

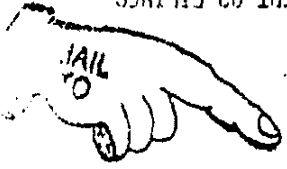

EXHIBIT "A"

LEGAL DESCRIPTION

Three (3) Parcels of Land in the East Half of Section 2, Township 42 North, Range 10 East of the Third Principal, which parcels are more particularly described as follows:
