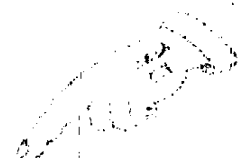

LEGAL DESCRIPTION

PARCEL 0A40005

JOB NO. R-90-012-89

That part of Lot 11 in Circuit Court Partition, a Subdivision of Northeast Quarter of Section 32 and the West half of the Northwest Quarter of Section 33, Township 35 North, Range 14 East of the Third Principal Meridian, according to the plat thereof recorded May 5, 1900 as Document 2956680, in Cook County, Illinois, described as follows:

Commencing at the Southwest corner of Lot 11 aforesaid; thence on an assumed bearing of North 83 degrees 39 minutes 38 second East along the South Line of said Lot 11, being also the centerline of Sauk Trail Road, a distance of 98.27 feet for a point of beginning; thence North 00 degrees 57 minutes 13 seconds West, 53.15 feet; thence North 83 degrees 39 minutes 38 seconds East, 66.29 feet; thence South 48 degrees 41 minutes 42 seconds East, 20.18 feet to a point on a line 38.00 feet North of and parallel with the South line of Lot 11 aforesaid; thence North 83 degrees 39 minutes 38 seconds East along said parallel line, 134.47 feet to a point on the East line of Grantor's Property; thence South 06 degrees 20 minutes 22 seconds East along said East line, 38.00 feet to the South line of Lot 11 aforesaid; thence South 83 degrees 39 minutes 38 seconds West along said South line, 219.35 feet to the point of beginning, containing 0.215 acres of land, of which 0.195 acres are already being used for roadway purposes.
