LEGAL DESCRIPTION

PARCEL 0A40007

That part of Lot 12 in Circuit Court Partition, a Subdivision in the Northeast Quarter of Section 32 and the West half of the Northwest Quarter of Section 33, Township 35 North, Range 14 East of the Third Principal Meridian, according to the plat thereof recorded May 5, 1900 as Document 2956680, in Cook County, Illinois, described as follows:

Commencing at the Southwest corner of Lot 11 in Circuit Court Partition aforesaid, thence on an assumed bearing of North 83 degrees 39 minutes 38 seconds East along the South line of said Lot 11, being also the centerline of Sauk Trail Road, a distance of 417.62 feet for a point of beginning; thence continuing North 63 degrees 39 minutes 38 seconds East along said South line, 120.00 feet to a point on the East line of Grantor's Property; thence North 06 degrees 20 minutes 22 seconds West along said East line, 38.00 feet; thence South 83 degrees 39 minutes 38 seconds West, 120.00 feet; thence South 06 degrees 20 minutes 22 seconds East, 38.00 feet to the point of beginning containing 0.105 acres of land of which 0.091 acres are already being used for roadway purposes.
