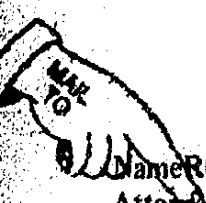

LEGAL DESCRIPTION

PARCEL 0A40006

JOB NO. R-90-012-89

That part of Lots 11 and 12 in Circuit Court Partition, a Subdivision of the Northeast Quarter of Section 32 and West half of the Northwest Quarter of Section 33, Township 35 North, Range 14 East of the Third Principal Meridian, according to the plat thereof recorded May 5, 1900 as Document 2956680, in Cook County, Illinois described as follows:

Commencing at the Southwest corner of Lot 11 aforesaid; thence on an assumed bearing of North 83 degrees 39 minutes 38 seconds East along the South line of said Lot 11, being also the centerline of Sauk Trail Road, a distance of 317.62 feet for a point of beginning; thence North 06 degrees 20 minutes 22 seconds West along the West line of the Grantor's Property, 38.00 feet; thence North 83 degrees 39 minutes 38 seconds East, 100.00 feet to a point on the East line of the Grantor's Property; thence South 06 degrees 20 minutes 22 seconds East along said East line, 38.00 feet to the South line of Lots 11 and 12; thence South 83 degrees 39 minutes 38 seconds West along said South line, 100.00 feet to the point of beginning, containing 0.087 acres of land of which 0.076 acres are already being used for roadway purposes.
