LEGAL DESCRIPTION

That part of Lot 12 in Circuit Court Partition, a Subdivision of the Northeast Quarter of Section 32 and the West half of the Northwest Quarter of Section 33, Township 35 North, Range 14 East of the Third Principal Meridian, according to the plat thereof recorded May 5, 1900 as Document 2956680, in Cook County, Illinois, described as follows:
