CLAIM FOR MECHANIC'S LIEN

In the Office of the Recorder of Deeds, Cook County, Illinois:

1. The undersigned claimant, SUBURBAN GAS SERVICE and DEL GROVES, of the County of Lake, Village of Round Lake Park, State of Illinois, by GANTAR & DeMARTINI, LTD., duly authorized agent in this behalf, makes the following statement and claims a Mechanic's Lien under the Law entitled An Act to Revise the Laws in Relation to the Mechanic's Liens approved May 18, 1903 and enforced July 1, 1903 and all amendments thereto, and states:

2. That the real property known and described as follows:

That part of the Southeast Quarter (except the East 28 acres, and except the North 110 feet thereof) of the Northwest Quarter of Section 5, Township 42 North, Range 10 East of the Third Principal Meridian, described as follows: Commencing at the Southwest corner of said East 28 acres and running thence North along the West line of said East 28 acres, 862.68 feet to the place of beginning; thence continuing North along the last described course, 142.40 feet; thence on a 71 degree, 32 minute, 39 second angle to the left of the last described course, 299.67 feet; thence on a 120 degree, 11 minute, 04 second angle to the left of the last described course, 240.00 feet; thence East 235.91 feet to the place of beginning, all in Cook County, Illinois. Subject to a 30.0 foot easement for egress and ingress on, over and across the East 30.00 feet of the South 1015.08 feet of that part of the Southeast Quarter of the Northwest Quarter of Section 5, Township 42 North, Range 10 East of the Third Principal Meridian, lying West of the East 28 acres, all in Cook County, Illinois.

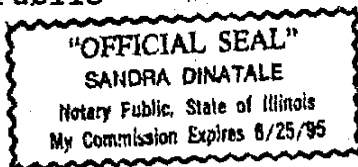
