Subject to: general real estate taxes not due and payable at the time of closing, special taxes or assessment; for improvements not yet completed and other assessments or installments thereof not due and payable at the time of closing, the Act, the Condominium Documents, including all amendments and exhibits thereto; applicable zoning and building laws and ordinances and other ordinances of record, encroachments if any, leases and licenses affecting the Common Elements, easements, agreements, conditions, covenants, building lines, party wall rights and restrictions of record, possible rights of Chicago Tunnel Company and Chicago Warehouse and Terminal Company, and all persons claiming thereunder, to tunnels located under the land, acts done or suffered by Purchaser or anyone claiming by, through or under Purchaser and liens and other matters of title over which Ticor Title Insurance Company is willing to insure at Seller's Expense.
