CERTIFICATE OF CORRECTION

The undersigned executed and caused the recordation of a release deed in the Office of the Cook County Recorder of Deeds on August 23, 1991 as Document No. 91433657 relative to the real estate described on Exhibit A attached hereto.

This instrument is intended to correct certain typographical errors in the aforesaid release deed as follows:

1) The legal description for the property identified as 4816 Prestwick Place should refer to Lot 12 instead of Lot 2.

2) The legal description for the properties identified as 4874, 4876, 4878 and 4880 Prestwick Place all show as measured perpendicularly to the "northwesterly line" and this reference should read "southeasterly".

3) The legal description for the property at 4890 Prestwick Place reflects a measurement of 92.40 feet and this measurement should instead be 92.49 feet.

4) The legal description for the property at 4891 Prestwick Place reflects a measurement of 108.43 feet and this measurement should instead be 108.50 feet.

5) The legal description for the property at 4835 Prestwick Place reflects a measurement of 139.62 feet and this measurement should instead be 139.32 feet.

The aforesaid release deed is hereby amended as set forth in this Certificate of Correction, which amendment shall relate back to the date the release deed was recorded as fully and with the same force and effect as if the matters set forth herein were incorporated into the original release deed.



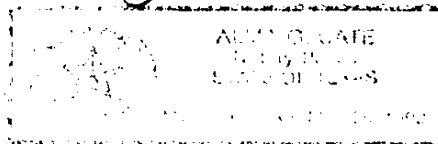
