

IT IS HEREBY ORDERED that:

The Trustees are hereby awarded judgment in the amount of \$5,145,597 against defendants People's Financial Services, Inc. ("People's Financial") and U.S. Remodeling and Home Improvement Corp. ("U.S. Remodeling") on Counts II, III, IV, V, VI and VII of the Complaint filed by the Trustees in this action.
