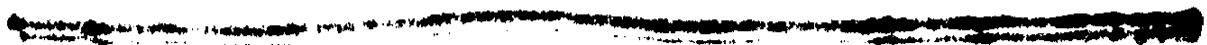

LEGAL DESCRIPTION OF PARCEL 0014

That part of the West 200 feet of the East half of the Northwest Quarter of Section 33, Township 35 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois described as follows:

Beginning at the Northeast corner of Lot 13 in Circuit Court Partition, a Subdivision of the Northeast Quarter of Section 32 and the West half of the Northwest Quarter of Section 33, Township and Range aforesaid, according to the plat thereof recorded May 5, 1900 as Document Number 2956680; thence on an assumed bearing of South 00 degrees 35 minutes 04 seconds East along the East line thereof, 50.25 feet; thence North 83 degrees 39 minutes 38 seconds East, 5.68 feet to a point on a line 50.00 feet South of and parallel with the centerline of Sauk Trail Road; thence North 82 degrees 15 minutes 06 seconds East along said parallel line, 195.89 feet to the East line of the West 200.00 feet of the East half of the Northwest Quarter of Section 33 aforesaid; thence North 00 degrees 35 minutes 04 seconds West along said East line, 50.39 feet to the centerline of Sauk Trail Road; thence South 82 degrees 15 minutes 06 seconds West along said centerline, 201.58 feet to the point of beginning, containing 0.271 acres of which 0.153 acres are already being used for highway purposes.
