) will give Lender all notices or bills that I receive for the amounts due under this Paragraph 2.

(ii) Lender's Obligations

If I make my payments to Lender, Lender will estimate from time to time my yearly taxes, hazard insurance premiums, assessments, leasehold payments, ground rents and mortgage insurance premiums, which items will be called the "impound/Escrow Items." Lender will use existing assessments and bills and reasonable estimates of future assessments and bills to estimate the impound/Escrow Items. The amounts that I pay to Lender for impound/Escrow Items under this Paragraph 2 will be called the "Funds."

4. BORROWER'S OBLIGATION TO PAY CHARGES, ASSESSMENTS AND CLAIMS

I will pay all taxes, assessments and any other charges and fines that may be imposed on the Property and that may be superior to this Security Instrument.

I will also make payments due under my lease if I am a tenant on the Property and I will pay ground tents (if any) due on the Property. I will pay these amounts either by making the payments to Lender that are described in Paragraph 2 above or by making the payments on time to the Person owed them.

Any claim, demand or charge that is made against property because an obligation has not been fulfilled is known as a //en. 5. BORROWER'S OBLIGATION TO MAINTAIN INSURANCE

At my sole cost and expense, I will obtain and maintain hazard insurance to cover all buildings and other improvements that now are or in the tuture will be located on the Property. The insurance must cover loss or dainage caused by fire, hazards normally covered by "extended coverage" hazard insurance policies and other hazards for which Lender requires coverage. The insurance must be in the amounts and for the periods of time required by Lender. I may choose the insurance company but my choice is subject to Lender's approval, Lender may not refuse to approve my choice unless the refusal is reasonable. All of these insurance policies and renewals of the policies must include what is known as a Standard Mortgages Clause to protect Lender. The form of all policies and renewals must be acceptable to Lender. Lender will have the right to hold the policies and renewals. If Lender requires, I will promptly give Lender all receipts of paid premiums and renewal notices that I receive.

If 1 of the earthquake insurance, any other hazard insurance, credit life and/or disability insurance, or any other insurance of or relating to the Property or the Secured Notes and which are not specifically required by Lender, I will name Lender as loss payed of any proceeds.

If there is a loss or damage to the Property, I will promptly notify the proper insurance company and Lender. If I do not promptly prove to the insurance company that the loss or damage occurred, then Lender may do so.

The amount paid by the insurance company is called "Proceeds." Any Proceeds received will be applied first to reimburse Lender for costs and expenses incurred in connection with obtaining the Proceeds, and then, at Lender's option and in the order in proportion as Lender may determine in its sole and absolute discretion, regardless of any impairment or tack of impairment of security, as follows: (A) to the extent allowed by applicable law, to the Surns Secured in malner that Lender determines and/or (B) to the payment of costs and expenses of necessary repairs or to the execution of the Property to a condition satisfactory to Lender, such application to be made in the manner and at the times as determined by Lender.

If I abandon the Property or if I do not a swer, within 30 days, a notice from Lender stating that the insurance company has offered to settle a claim, Lender may collect the Proceeds. Lender may use the Proceeds to repair or restore the Property or to pay the Sums Secured. The 30-day period will begin when the notice is diven.

If any Proceeds are used to reduce the amount of principal which I owe to Lender under the Secured Notes. That use will not detay the due date or change the amount of any of my monthly payments under the Secured Notes and under Paragraphs 1 and 2 above. However, Lender and I may agree in writing to defays or changes.

If Lender acquires the Property under Paragraph 27 below, all of my lights in the insurance policies will belong to Lender. Also, all of my rights in any proceeds which are paid because of damage that occurred belong the Property is acquired by Lender or sold will belong to Lender. However, Lender's rights in those proceeds will not be greater than the Sums Secured immediately before the Property is acquired by Lender or sold.

If I am required by Lender to pay premiums for mortgage insurance, I will by the premiums until the requirement for mortgage insurance ends according to my written agreement with Lender of according to law.

6. BORROWER'S OBLIGATION TO MAINTAIN THE PROPERTY AND TO FELFILL ANY LEASE OBLIGATIONS

I will keep the Property in good repair. I will not destroy or substantially change the Property and I will not allow the Property to deteriorate. I will keep and maintain the Property in compliance with in state or tederal hazardous materials and hazardous waste laws. I will not use, generate, manufacture or store any hazardous materials or hazardous waste on, under or about the Property. I will indemnify, defend and hold harmless Lender and its employees, officers and directors and their successors from any claims, damages or costs for required or necessary repair or the removal of hazardous waste or any other hazardous materials claim. If I do not own but am a tenant on the property, I will fulfill my obligations under my lease. I also agree that, if I acquire the fee liftle to the Property, my lease interest and the fee title will not merge unless Lender agrees to the merger in writing.

7. LENDER'S RIGHT TO PROTECT ITS RIGHTS IN THE PROPERTY

If: (A) I do not keep my promises and agreements made in this Security Instrument, or (B) someone, including me, begins a legal proceeding that may significantly affect Lender's rights in the Property (such as a legal proceeding in bankruptcy, in probate, for condemnation or to enforce laws or regulations), then Lender may do and pay for whatever is necessary to protect the Lender's rights in the Property. Lender's actions may include appearing in court, paying reasonable attorneys' fees and entering on the Property to make repairs. Lender must

I will pay to Lender any amounts which Lender advances under this Paragraph 7 with Interest, at the interest rate in effect under the Secured Notes which have not been paid, I will pay those amounts to Lender when Lender sends me a notice requesting that I do so, interest on each amount will begin to accrue on the date that the amount is advanced by Lender. 8. LENDER'S RIGHT TO INSPECT THE PROPERTY

9. AGREEMENTS ABOUT GOVERNMENTAL TAKING OF THE PROPERTY

I assign to Lender all my rights: (A) to proceeds of all awards or claims for damages resulting from condemnation, emited domain or other governmental taking of all or any part of the Property; and (B) to proceeds from a site of all or any part of the Property that is made to avoid condemnation, eminent domain or other government lating of the property. If all of the Property is taken, the proceeds will be used to reduce the Sums Secured. If any of the proceeds remain after the amount that I owe to Lender has been paid in full, the remaining proceeds will be paid to me. Unless Lender and Lagros otherwise in writing, if only a part of the Property is taken, the amount that I owe to Lender will be reduced only by the amount of proceeds multiplied by the following fraction: (A) the total amount of the Sums Secured immediately before the taking, divided by (B) the fair market value of the Property immediately before the taking. Its remainder of the proceeds will be paid to me.

If I abandon the Property or If I do not answer, within 30 days, a notice from Lender stating that a governmental authority has offered to make a payment or to settle a claim for damages, Lender has the authority to callect the proceeds. If any proceeds are used to reduce the amount of principal which I owe to Lender under the Secured Notes, that use will not delay the due date or change the amount of any of my monthly payments under the Secured Notes and under Paragraphs 1 and 2 above. However, Lender and I may agree in writing to delays or changes.

10. CONTINUATION OF BORROWER'S OBLIGATIONS AND OF LENDER'S RIGHTS

(A) Borrower's Obligations

Lender may allow a Person who takes over my right; and obligations subject to this Security Instrument to delay or to change the amount of the monthly payments of principal and interest due under the Secured Notes or under this Security Instrument. Even If Lender does this however, that Person and I will both still be fully obligated under the Secured Notes and under this Security Instrumer.

Lender may allow those delays or changes for a Person who takes one my rights and obligations, even it Lender is requested not to do so. (B) Lander's Rights

Even if Lender does not exercise or enforce any of its rights under this Security instrument or under the law, Lender will still have all of those rights and may exercise and enforce them in the fiture. Even if Lender obtains insurance, pays taxes, or pays other claims, charges or liens against the Property, Lender the right under Paragraph 27 below to demand that I make immediate payment in full of the amounts that I owe to Lender under the Note and under this Security Instrument.

11. OBLIGATIONS OF BORROWER AND OF PERSONS TAKING OVER BORROWER'S RIGHTS OR OBLIGATIONS

Any Person who takes over my rights or obligations under this Security Instrument will have all of my rights and will be obligated to keep all of my promises and agreements made in this Security Instrument. Similarly, any Person who takes over Lender's rights or obligations under this Security Instrument will have all of Lender's rights and will be obligated to keep all of Lender's agreements made in this Security Instrument.

If more than one Person signs this Security Instrument as Borrower, each of us is fully obligated to keep all of Borrower's promises and obligations contained in this Security Instrument. Lender may enforce Lender's rights under this Security Instrument against each of us individually or against all of us together. This means that any one of us may be required to pay all of the Sums Secured.

12 MAXIMUM LOAN CHARGES

If the loan secured by this Socurity instrument is subject to a law which sels maximum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed permitted limits, then: (A) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limits and (B) any sums already collected from Bottower which exceeded permitted limits will be refunded to Bottower. This Security Instrument and the Secured Notes shall be governed by and construed under federal law and federal rules and regulations including those for federal savings and loan associations, called "Federal Law," in the event that any of the terms or provisions of this Security Instrument or the Secured Notes are interpreted or construed by a court of competent jurisdiction to be vold, invalid or unenforceable, such decision shall affect only those provisions or construed or interpreted and shall not affect the remaining provisions of this Security Instrument or the Secure, Notes.

16. BORROWER'S COPY

I acknowledge the receipt of one conformed copy of the Secured Notes and of this Security Instrument.

17. LENDER'S RIGHTS TO RENTAL PAYMENTS AND TO TAKE POSSESSION OF THE PROPERTY

It Lender requires immediate payment in full or it I abjecton the Property, then Lender, persons authorized by Lender, or a receiver appointed by a court at Lender's requer, may: (A) collect the rental payments, including overdue rental payments, directly from the tenants; (B), enter upon and take possession of the Property; (C) manage the Property; and (D) sign, cancel and change rental agreements and leases.
