

After the allowance of all credits, the Claimant is entitled to the sum of \$14,049 for which, with interest after July 26, 1991, the Claimant claims a lien on the aforesaid land and improvements thereon, and on the monies or other considerations due and to become due from or on behalf of the Owner.



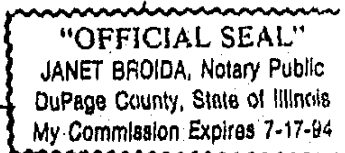
