MODIFICATION/EXTENSION AGREEMENT

and, Whereas the Parties hereto wish to extend the term and change the interest rate and repayment thereunder.

Now, therefore, it is agreed to extend the time of payment of the unpaid balance presently due and owing in the amount of \$169,892.96 until the 20th day of December, 1996.

It is further agreed by the parties hereto that the Note or other Obligation evidencing said indebtedness shall be and is hereby modified to provide that said balance of \$169,892.96 shall bear interest at the rate of 8.59% per annum beginning December 30, 1991 and continuing during the term hereof, and at the rate of TWELVE per cent (12.0%) per annum upon default or after maturity, and shall be payable in monthly installments of \$1,497.64, principal and interest, beginning on the 30th day of January, 1992 and continuing on the 30th day of each and every month thereafter until the 30th day of December, 1996 at which time the entire outstanding balance of principal plus interest shall be due, if not sooner paid.

In all other respects said Note or other obligation and said mortgage shall remain unchanged and be in full force and effect.
