TOGETHER with all and singular the timements hered terms s and appartenances thereunto belonging, and the rents, issues, and profits thereor; and all includes now or nereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are, and shall be deemed to be, lixtures and a part of the realty, and are a portion of the security for the indebtedness herein mentioned;

At Mortgagee's option, Mortgagor will pay a "late charge" not exceeding four per centum (4%) of any installment when paid more than lifteen (15) days after the due date thereof to cover the extra expense involved in handling delinquent payments, but such "late charge" shall not be payable out of the proceeds of any sale made to satisfy the indebtedness secured hereby, unless such proceeds are sufficient to discharge the entire indebtedness and all proper costs and expenses secured hereby.

Notwithstanding anything to the contrary set forth in the Instrument, Mortgagee and Mortgager hereby acknowledge and agree to the following:

GUARANTY: Should the Department of Peteraus Affairs fail or refuse to issue its guaranty in full amount within 60 days from the date that this loan would normally become eligible for such guaranty committed upon by the Department of Veteraus Affairs under the provisions of Title 38 of the U.S. Coo. "Veteraus Benefits", the Mortgages may declare the indebtedness hereby secured at once due and payable and may forcefore in mediately or may exercise any other rights hereunder or take any other proper action as by law provided.

- (a) ASSUMPTION FUNDING FEE: A fee equal to one harf of 1 percent (.50%) of the unpaid principal belance of this loan as of the date of transfer of the property shall be payable at the date of transfer to the unorigages or its authorized agent, as trustee for the Secretary of Veterans Alfairs. If the assumer fails to ray this fee at the time of transfer, the fee shall constitute an additional debt to that already secured by this instrument, shall bear interest at the rate herein provided, and, at the option of the mortgages of the indebtedness hereby secured or any transferse thereof, shall be immediately due and payable. The amount of this charge shall not exceed the lesser of the maximum established by the Department of Veterans Afficies for a loan to which Section 1814 of Chapter 37, Title 38, United States Code applies or any maximum prescribed by applicable State law.
- (a) ASSUMPTION INDEMNITY LIABILITY: If this obligation is assumed, then the argument hereby agrees to assume all of the obligations of the veteran under the terms of the instruments creating and securing the loan including the obligation of the veteran to indemnify the Department of Veterans Affairs to the extent of any claim payment arising from the guaranty or insurance of the indebtedness created by this instrument.
