BE IT ORDAINED by the President and Board of Trustees of the Village of Northbrook, County of Cook and State of Illinois THAT:

AN ORDINANCE VOLUNTARILY ANNEXING CERTAIN TERRITORY CONTIGUOUS TO THE VILLAGE OF NORTHBROOK AND ESTABLISHING ZONING THEREOF

be and is hereby adopted as follows:

Section 1. REAL ESTATE ANNEXED.

The Village of Northbrook, pursuant to Chapter 24. Article 7-1-8 of the Illinois Municipal Code, hereby annexes the territory legally described as:

The North 100 feet of the West 249.33 feet of that part of the South 400 feet of the North 1/2 of the Northwest 1/4 of Section 22. Township 42 North. Range 12 East of the Third Principal Meridian lying westerly of the right of way of the former Des Plaines Valley Railroad now the Chicago and Northwestern Railroad (except that part condemned by Case tr. 69 L 15167), including the full right-of-way of Shermer Road fronting the property, all in Cook County, Illinois, and commonly known as 2565 Shermer Road. Northbrook, Illinois (PREI No. 04-22-100-026).

Section 1. FIRE DISTRICT NOTIFICATION

An affidavit, certifying proper notification to the Northbrook Rural Fire Protection District in accordance with State Statutes, shall be recorded with this document.

Section 3. ZONING.

Zoning of the above-described territory is hereby established and authorized for use as provided in the Northbrook Zoning Code (1988), as amended. Subsection 2-104A, in the C-3 Central Pusiness District.

Section 4. PLAT OF ANNEXATION.

A plat of the above-described territory is hereby made a part of this Ordinance by attachment.

Section 5. RECORDATION.

The Village Manager is hereby directed to cross a certified copy of this Ordinance, together with an accurate plat and afridayit, certifying proper notification to the proper public bodies, in accordance with State Statutes, to be recorded with the Recorder of Deeds of Cook County, Illinois.

Section 6. REPORTING.

The Village Clerk shall report this annexation by serving a document of annexation by registered or certified mail on the Election Authorities and Clerk of Cook County, Illinois, and on the United States Post office branches serving the annexed territory within 30 days of the passage of this ordinance, as required by law.

Section 7. EFFECTIVE DATE.

This Ordinance shall be in full force and effect upon passage and publication in pamphlet form in accordance with State Statutes.
