WITNESSETH

WHEREAS, the Mortgagee has heretefore loaned the Borrowers the principal sum of TWO HUNDRED THOUSAND AND MO/100 DOLLARS (\$200,000.00) which loan is evidence by a promissory note being hereinafter referred to as the "Note", dated as of NOVEMBER 9, 1990 executed by Borrowers and payable to the order of the Mortgagee, with final payment due on MAY 1, 1991.

WHEREAS, the Note is secured by a mortgage of even date therewith being hereinafter referred as to the "Mortgage" executed by the Ber ower creating a lien on certain real property located in COOK County, Illinois and legally described on Exhibit A attached hereto, which Mortgage was recorded with the Recorder of Deeds for said county on NOVEMBER 13, 1990 as document number 90552809 and, MORTGAGE MODIFICATION AGREEMENT DATED MAY 1, 1991 (MOORDED AS DOCUMENT NUMBER 91300106 AND, MORTGAGE MODIFICATION AGREEMENT DATES VOLY 1, 1991 RECORDED AS DOCUMENT NUMBER 91414090 AND,

WHEREAS, the Borrowers and the Mortgagee desire to modify the terms for the payment of the Note as hereinafter provided.

NOW, THEREFORE, in consideration of the mutual covenants hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Borrowers and the Mortgagee do hereby agree as follows:

The principal indebtedness evidenced by the Note presently outstanding is ONE HUNDRED NINETY SIX THOUSAND AND NO/100 DOLLARS (\$196,000.00) which shall be paid as follows:

PRINCIPAL AND ACCRUED INTEREST SHALL BE PAID IN FULL ON MARCH 1, 1992.

- 2. All referenced in the Mortgage to the Note shall refer to the Note as herein modified.
- 3. All references in the Note to the Mortgage shall refer to the Mortgage as herein modified.
- 4. Environmental Warranties and Agreements. Mortgagor warrants and represents to, and agrees with, Bank as follows:
- (a) The premises, and all operations and activites thereon, are and shall continue to be in compliance with all environmental laws, and the premises are not and shall not become (i) contaminated by, or the site of the dispodal or release of, and hazardous substance, (ii) the source of any contamination, by any hazardous substance, of any adjacent property or of any groundwater or surface water, or (iii) the source of any are emission in excess of any legal limit now or hereafter in effect; and, except as expressly disclosed by Mortgagor to Bank in writing, no asbestos or polychlecimated biphenyls are present or contained in or on the premises.
- (b) Mortgagor shall take all actions necessary to investigate, clean up, and eliminate the source of, any past, present or future contamination of the premises by any hazardous substance and to prevent any additional contamination of the premises. The taking of action by Mortgagor under this subparagraph (b) shall not limit any other right or remedy available to Bank by reason of any such contamination (including Bank's right to accelerate payment of the Indebtedness).
- (c) For purposes of this Mortgage, (i) "environmental low" means any past, present or future federal, state, local or foreign law, ordinance, rule, regulation or order that regulates or is intended to protect public health or the environment or that establishes liability for the investigation, removal or clean-up of, or damage caused by any environmental contamination, including, without limitation, any law, ordinance, rule, regulation or order that regulates or prescribes requirements for air quality, water quality, or the disposition, transportation or management of waste materials or toxic substances; (ii) "hazardous substance" means any product or waste that is now or hereafter regulated by or subject to any environmental law and any other hazardous substance, pollutant, contaminant or waste, including, without limitation, asbestos and polychlorinated biphenyls; and (iii) property shall be considered to be "contaminated" by a hazardous substance if a hazardous substance is present on or in the property in any amount of level.
- 5. The Borrowers hereby restate and reaffirm each and every representation, warrant, covenant and agreement contained in the note and the Mortgage as fully as if such representations, waranties, covenants and agreements were set forth herein.
