was presented for filing on October 2, 1987.

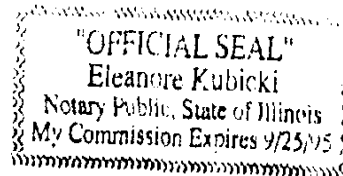
