Changes in the interest rate are governed by changes in the Annual Percentage Rate (APR) which is equal to the Index Plus a Margin as described in the Note and Agreement. The Index is the highest prime rate as announced from time to time by The Wall Street Journal. However, the Annual Percentage rate (APR) shall at no time be reduced to a rate lower than eight (8.0%) percent per annum. The Maximum Interest Rate will not exceed eighteen percent (18.0%). In the event that all of the borrowers cease to use the property as their principal residence, then Lender may, at lander's option, declare all the sums secured by this Mortgage immediately due and payable.

### XXV. RELEASE

Upon payment of all sums secured by this Mortgage, Lender shall release this Mortgage without charge to Borrower.

### XXVI. WAIVER OF HOMESTEAD

Borrower hereby waives all right of howestead exemption in the Property.

The captions and headings of the paragraphs of this Mortgage are for convenience only and are not to be used to interpret or define the provisions hereof.
