NOTICE OF LIEN

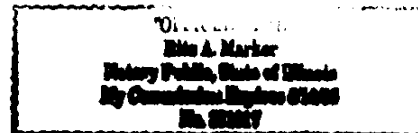
2. There is presently due, and unpaid, to the Village of Crestwood the amount of \$1,073.35 for such water service.
