## ORDER APPROVING REPORT OF SALE AND DISTRIBUTION AND ORDER FOR POSSESSION

IT IS FURTHER ORDERED that the Sheriff of Cook County remove all parties now in possession of the subject premises, commonly known as 14425 Sanderson, Dolton, IL and that he put the plaintiff/bidder or their nominee into full and complete possession thereof. This Order shall remain in effect for six months hereof.

IT IS FURTHER ORDERED that the Registrar of Deeds, of Cook County, Illinois register the Deed issued in this action without requiring the Surrender of the Original Mortgagee's Torrens Certificate.
